# **Practice Management**

<u>For the creation of a custom portfolio</u>: In the initial meeting with the client the objective is to understand their financial needs, objectives, preferences, and risk tolerance. Then we fashion an investment plan along with a diversified investment portfolio designed to address that need. Diversification entails a combination of several asset classes, styles and sectors.

The investment portfolio itself is made up of Exchange Traded funds (ETF's) and Mutual funds which are mostly indexed to keep the portfolio cost effective and reduce its tracking error relative to benchmarks. The portfolios are then paired with actively managed investments and alternative strategies with the goal of producing consistent alpha.

When matching clients to a constructed portfolio: Clients with long, time horizons and high, risk tolerances get designated a higher allocation to equity and alternative strategies in their portfolio. The expectation for each portfolio, along with an idea of drawdowns and volatility are explained in detail to clients before they make their decision.

<u>Investment Management Fees</u>: Investment Advisory fees of 1% are charged on the market value per annum, pro-rated and charged monthly for model portfolios (Conservative to Aggressive) and the QIM leveraged equity strategy. Fees for the QIM Absolute Return strategy are at 1/5% of market value per annum, pro-rated and charged monthly.

<u>Financial Planning Fees</u>: Financial planning is done through a robust financial planning software called MoneyGuide. The objective of which is to determine and increase the probability of a client reaching their desired, inflation-adjusted retirement lifestyle with the investment capital they have. There currently is no charge for financial planning services.

<u>Performance Reporting and Portfolio Reviews</u>: Time-weighted Performance is measured daily and available through a program called Envestnet. Customized reports are made available to clients either on request or through Envestnet's online portal.

Fidelity also sends out monthly statements to clients (through email or by regular mail) and reports performance through their own online portal.

Portfolio performance relative to its benchmark is reviewed every 6 months with the clients. The 6 month interval is measured from their account opening date.
